Equipment and Materials Upgrade Grant Application

Deadline: Must be postmarked on or before October 31, 2010

Overview:

The Kansas State-Provider Cooperation Committee (SPCC), composed of Child Care Providers Together (CCPT), the Department of Social and Rehabilitation Services, and the Kansas Department of Health and Environment, has established a Health and Safety Fund to assist home based child care providers improve the quality of care they provide to Kansas families by adopting the best practices in health, safety, and early learning.

With resources provided by the American Recovery and Reinvestment Act (ARRA), the Health and Safety Fund is providing Equipment and Materials Upgrade Grants to home based providers who need additional resources to meet required health and safety standards, create or enhance the early learning and development of children in their care, replace damaged or worn out materials, and increase the sustainability of their child care business. The goals of the SPCC are to increase the availability of safe, quality, and affordable child care for Kansas families through the Health and Safety Fund and this grant program.

Grants will be awarded to those applicants whose projects closely reflect the goals of the Health and Safety Fund, are well documented in terms of established need, description, and proof of cost estimates, and whose regulatory compliance record and professional development demonstrate a professional commitment to safe, healthy, high quality child care and early learning.

Use of Equipment and Materials Upgrade Grants:

The Equipment and Materials Upgrade Grants will be awarded to home based child care providers for a wide range of projects that achieve educational, licensing, and health and safety improvements to home based child care facilities, including such projects as (but not limited to these examples):

- ✓ Child safe car seats
- ✓ Audio/visual equipment and learning materials
- ✓ Books
- ✓ Toys

Eligibility:

The Equipment and Materials Upgrade Grants will be awarded to eligible home based child care providers only. To be eligible, home based child care providers must offer proof of the following criteria:

- ✓ Full and Complete Application
- ✓ Kansas business address
- ✓ Proof of current registration or license
- ✓ Proof of twelve (12) months of current and continuing registered or licensed child care in Kansas
- ✓ Proof of Completion/Certification of Infant/Child First Aid, CPR, and Safe Sleep/SIDS
